

UTD DUES FOR 2008-2009

DUES AMOUNTS

The dues amounts for the 2008-2009 school year are listed below and apply to both 10 and 12-month employees:

Full-time teachers and interim teachers (permanent substitutes)	— \$802.20*
Full-time paraprofessionals, security monitors and secretaries/clerks	— \$401.10
Job-sharing teachers	— \$401.10
Full-time teachers on leave	— \$200.55
Full-time paraprofessionals, security monitors and secretaries/clerks on leave	— \$100.28
Part-time teachers, paraprofessionals, security monitors, and half-time teachers	— \$100.28
Temporary Instructors (emergency and pool substitutes)	— \$212.40**

*Includes legislative fund.

**This amount only applies to those temporary instructors electing to make cash payments for their dues. See below for payroll deduction information.

PAYROLL DEDUCTION INFORMATION

Payroll deduction members of UTD will be deducted as follows:

All full-time teachers — 20 deductions at \$40.11 each
All full-time paraprofessionals, security monitors and clericals — 20 deductions at \$20.06 each
All part-time employees — 10 deductions at \$10.03 each
Temporary instructors — 1.25% of daily rate deducted only on days worked**

**Daily rate of \$60.00 = \$0.75 per day; \$69.00 = \$0.86 per day; \$77.00 = \$0.96; \$86.00 = \$1.08; \$94.00 = \$1.18 per day; \$111.00 = \$1.39 per day; \$120.00 = \$1.50 per day; and \$137.00 = \$1.71.

Deductions for all employees begin on **September 12, 2008**. Deductions do **NOT** have to be made up for those employees who join through payroll deduction later in the year.

Job-sharing teachers, half-time teachers, and on-leave employees are not eligible for payroll deduction and must pay their dues by cash payment.

CASH PAYMENT INFORMATION

All full-time employees who pay cash dues may make their cash payments in 4 equal installments, with the balance to be paid in full by **December 15, 2008**. **Cash dues are not prorated and any cash dues paid after December 15 of the current school year must be for the full amount.**

Full-time teachers — 4 payments of \$200.55 each
Full-time paraprofessionals, security monitors and secretaries/clerks — 4 payments of \$100.28 each
Job-sharing teachers — 4 payments of \$100.28 each
On leave teachers — 2 payments of \$100.28 each
On leave paraprofessionals, security monitors and secretaries/clerks — 2 payments of \$50.14 each
Part-time employees and half-time teachers — 3 payments of \$33.43 each
Temporary Instructors — 4 payments of \$53.10 each

Credit card charges are accepted on MasterCard or VISA, but must be for the full amount of dues or the total balance due. Signature and expiration date is required.
